PROFESSIONAL SUMMARY

Maureen Johnson is an assistant clinical professor at UConn School of Law, where she teaches legal writing. She previously visited at William S. Boyd School of Law at UNLV, currently ranked by U.S. News as the top legal writing department in the nation. Maureen began her teaching career at Loyola Law School, Los Angeles, which also routinely has been ranked as a top-tier legal writing department. Maureen has authored five published law review articles. The bulk of her legal scholarship focusses on the intersection of social and legal rhetoric, with an emphasis on civil rights and antiracism. Maureen has substantial litigation experience, including working for six years at two worldwide law firms, Mayer Brown and Kaye Scholer LLP. She also worked at a boutique Beverly Hills plaintiff-side law firm where she focused almost exclusively on appellate work and major law and motion practice. One of the appeals she drafted and argued—*Global Hawk v. Le*—was favorably resolved and certified for publication by the First District of the California Court of Appeal.
