

Welcome

Zot! Zot! You are officially an Anteater. Welcome to the University of California, Irvine School of Law community! We are delighted that you have chosen to join us, and soon, you will be on campus, sitting in a classroom, feeling proud of what you've done for the opportunity to sit in that seat. But before you do, there is a lot of information you need to be aware of to ensure your transition to enrollment is seamless. This Pre-Matriculation Guide was written specifically for you to help you prepare for your journey to Irvine.

Orientation

Orientation is an opportunity for you to meet your peers, faculty, and members of the administration who will be integral to your law school success. While primarily coordinated by the Student Affairs Office, Orientation is a community effort to ensure you have the tools and resources to be successful in your 1L year. For the most updated information, please bookmark the Orientation website. This will include a tentative schedule as well as some action items you must complete prior to your arrival.

Orientation is mandatory and will take place Monday, August 12 – Friday, August 16. All students must have their ZOTKey (UCI Digital ID Card) to attend Orientation.

Academics & Curriculum

Our faculty has developed a cutting-edge curriculum that ensures students receive an education comparable to or exceeds that found at any top law school and addresses the changing demands of the legal profession.

Office of Student Services

The Office of Student Services assists students with any academic matter, including advising on course selection and sequencing, scheduling courses and course registration, counseling on academic matters (including issues of academic performance), and scheduling courses and implementing course registration. They also inform about Academic Rules, connect to the University's Disability Services Center for accommodations, and coordinate exam administration. Student Services also maintains all official student records, functions as the Registrar, and is the primary resource to all students regarding certification for admission to the bar.

1L Schedule

All 1Ls take the same classes during their first year, except for an elective course in the second semester. Student Services will register and assign you to an academic module (MOD). This is a smaller group of peers with whom you will take most of your 1L classes. Classes may be taught in different semesters depending on the student's module. You will receive your MOD assignment and individual schedule on the first day of Orientation. Please do not buy books until you receive your schedule as different professors use different textbooks.

Academic Policies

All [policies](#) related to academics, honor code, ABA Standards, conduct, etc. are overseen by Student Services. All law students are responsible for familiarizing themselves with and abiding by the rules and standards contained in all applicable policies of the University of California and the University of California, Irvine campus.

Disability Services Center (DSC)

The [UCI Disability Services Center](#) works closely with students to ensure they receive the accommodation they are entitled to. The first step in requesting accommodation is filling out the DSC Intake form. You then will be assigned a DSC staff member to help you with the process. Please note you must have activated your [UCINetID](#) to fill out the DSC Intake form.

Student Portal

Your Student Portal contains information on resources including the Student Directory, Academic Calendars, and services the Law School provides. You will receive access to your Student Portal after Orientation.

Academic Skills Program

The [Academic Skills Program \(ASP\)](#) is a resource for all students seeking to maximize their academic success through one-on-one consultation, workshops, and advising. From identifying the keys to effective class preparation, to solidifying legal analysis and legal writing skills, to demystifying the bar exam, ASP provides critical skills instruction to help students excel in all stages of their legal education. ASP will start their support during the summer before Orientation and fall classes by offering webinars and resources to prepare for law school. Throughout your three years at UCI Law, they will provide instruction and support for academic success.

Final Undergraduate Transcripts

Official undergraduate transcripts that show the degree conferral date must be submitted to the Law School Admission Council (LSAC) for inclusion in the CAS Report. All incoming UCI Law students with an undergraduate degree date of 2024 graduates must make sure their updated and final transcripts that show their degree conferral date are received in our office. The conferral date **must** be before our matriculation date, which is the first day of Orientation – August 12, 2024.

Graduate & Professional School Transcripts

UCI Law must receive final and official transcripts from all post-secondary institutions attended, including graduate or professional school. Even if a school includes summary data regarding courses from another school on its transcript, an official transcript from all institutions must be submitted.

All transcripts should be received by our office no later than July 31, 2024.

Character & Fitness - Continuing Duty to Report

Incoming students have an ongoing duty to report all character and fitness issues that may have arisen since submitting your application. If you can answer yes to any of the three character and fitness related questions that were on your application (see questions below), you must submit a statement to the Office of Admissions & Student Financial Services Office describing the situation.

If you need to amend an answer on your application to any of the questions below, even if the situation occurred prior to your application submission, you must send a statement to our office describing the situation and why it was not included in your admissions application at the time you applied.

All Character & Fitness Statements prior to your matriculation should be sent as a PDF to admissions@law.uci.edu.

The following questions were asked in your application.

- 1. Have you ever been convicted of, or is any charge now pending against you, of any crime other than a traffic violation?*
- 2. Have you ever been dismissed, suspended, placed on probation or disciplined by any college, university, graduate, or professional school, or is any such charge pending against you, or expected to be brought against you?*
- 3. Have you ever been subject to discipline by a professional organization or discharged from employment for conduct-related issues?*

Throughout the course of enrollment at UCI School of Law, students have a continuing duty to report to the Assistant Dean for Student Services any legal actions taken by or against the student, or charges brought by University disciplinary offices. Such actions include arrests, lawsuits, civil actions, and administrative proceedings. At the time students apply for Bar admission, the Bar authorities in each jurisdiction will seek to determine that the information in the Bar application is congruent with the UCI Law student file. Students must make any such matters known to the Assistant Dean for Student Services immediately on occurrence.

Financing Your Legal Education:

The Office of Student Financial Services determines eligibility for institutional financial aid and ensures that eligible students are appropriately awarded federal student aid. In addition to managing the delivery of all types of financial aid funds, it offers law students financial services in the form of loan counseling, advice on maintaining financial aid eligibility, debt management workshops, web-based tools to manage an education loan portfolio and Loan Repayment Assistance Program (LRAP).

Tuition and Fees

[Tuition and fees](#) are composed of Tuition, Professional Degree Supplemental Tuition, a Student Services Fee, and mandatory campus-based fees. Tuition and fees have been set regardless of the method of instruction and will not be refunded in the event instruction occurs remotely for any part of the Academic Year. Figures for tuition and fees represent currently approved or proposed amounts and may not be final. **Actual tuition and fees are subject to change by the University of California and will be assessed in early July 2024.**

Living Expenses and Books

The cost of living and book expenses are estimated and based on a modest but adequate standard of living. These costs are updated annually. The cost of living depends upon a student's personal situation and choices. Students have the choice to live in an on-campus or off-campus apartment. Each living arrangement has a different cost. The University of California Office of the President provides an example of typical off-campus housing costs near UCI. For detailed housing information, refer to the [housing](#) webpage.

UC Graduate Student Health Insurance (GSHIP)

The University of California requires all students to have major medical health insurance. All law students are automatically enrolled in the [UC Graduate Student Health Insurance Plan \(GSHIP\)](#), and the premium for this insurance is assessed each term on the law student's registration fee statement. **GSHIP Waiver:** Students may waive this fee if they apply for and meet [waiver criteria](#). Students can apply for a GSHIP waiver on the [UCI Student Health Center](#) website no later than **July 1, 2024**. Late waivers may be approved and are subject to a \$50 late waiver fee.

ZOT Account & Tuition Deadline

A [ZOT Account](#) reflects charges billed to you, as well as credits and payments made to your account. You can view charges, disbursements, refunds, and make payments via your ZOT Account. All fees for the fall 2024 semester must be paid in full by **August 15, 2024, at 4:00 p.m. Pacific Time**. A late fee of \$50 will be assessed for all late payments.

Scholarship Disbursements

If you have been awarded a UCI Law Scholarship, Need-Based Grant, or Fellowship, these funds will be disbursed to your ZOT Account on or around July 20.

Direct Loans

If you plan to borrow Federal Direct Student Loans to apply towards tuition, fees, and living expenses, you must accept the loan offers on the [ZotAid](#). Additionally, all students are required to complete the Master Promissory Note (MPN) and Entrance Counseling by signing into [studentaid.gov](#). This should be done as soon as possible. Loan funds will not be disbursed until this has been done.

Additional Loan Options

To cover tuition costs and living expenses that your financial aid offer does not cover, there are additional education loan options you can explore including the Federal Graduate PLUS Loan, Private Loans, and the Dreamers Graduate Loan Program. These loans all require an additional application and borrowers are encouraged to review the differences and terms for each [education loan](#) before applying.

Payment Plans

You may apply for the [PACE Installment Payment Plan](#). The PACE Plan spreads the cost of tuition and fees into three monthly installments over the semester. There is no charge to apply; however, every time you use the plan, you pay a nonrefundable PACE Participation Fee. More information about the PACE Plan is described in the [Payment Instructions](#).

Refunds

By mid-July, you will have access to your [ZOT Account](#) and can set up to receive funds electronically or by mail through Disbursements Electronic Fund Transfer (DEFT). DEFT allows you to choose how you want your financial aid refund to be disbursed: mailed paper check, or direct deposit. You can enroll for

either of these in your [Zot Account](#). Refunds for living expenses and books after Fall 2024 semester tuition and fees are fully paid will be sent to students on **August 16, 2024**.

International Students

International students can make an international payment with UCI's process partner, Western Union Global Pay (WUGP). Students connect with this service by clicking the "International Payment" button when viewing the Current Account webpage in [ZOT Account](#) Online. Third parties (i.e., parents) should access the Western Union Global Pay webpage directly and must supply their information in addition to the student's. WUGP offers a favorable exchange rate without expensive international wire fees. You lock in the rate and receive a confirmation webpage with a unique reference number valid for 72 hours (about 3 days). You then pay at your bank using your home country's currency. To ensure timely and accurate payment, be sure your bank includes the WUGP reference number when transferring funds. UCI receives your payment in the U.S. (United States). Dollars, usually within two business days from the date your bank initiates payment. Your ZOT Account is credited by the next business day. Please take these processing times into account when paying by the deadline; payment must be received (not initiated) by the date on your bill.

Statement of Legal Residence (SLR)

Admitted students must complete the [Statement of Legal Residence \(SLR\)](#). The SLR assists the main campus in assessing tuition and fees for students by determining their status as a California resident or as an out-of-state resident. The Student Financial Services Office highly recommends completing the SLR by **July 6, 2024**, to ensure that fees are accurately assessed. If you need assistance adjusting your residency after fees have been assessed, please contact [Student Financial Services](#).

Career Development Office (CDO)

The Career Development Office (CDO) at UCI Law supports you every step of the way in developing your unique career plan. Each UCI Law student works individually with an attorney advisor who conducts career counseling sessions, provides constructive feedback on application materials, and offers guidance to assist you in making informed career decisions and develop the professional skills necessary to enter the job market as competitive, practice-ready applicants.

UCINetID

Your UCINetID and password are your keys to access many UCI online services, including EEE+ and Canvas, WebReg, ZotPortal, UCI Lawnet Google, and on-campus computer systems. To access any of these services, students must first activate the [UCINetID](#).

Campus ID Card - ZotKey

A [Zotkeys](#) is your Campus ID is your key to services such as the library, the campus shuttle, student discounts, and more. You need to upload a photo for your ID to [UCI OneCard Account Manager](#). **Having your ZotKey is mandatory for Orientation, so photos should be uploaded no later than August 1, 2024.**

Community Fellows

The [Community Fellows](#) program was created to assist first-year students with the transition to law school and the culture at UCI Law. During new student orientation, each first-year student is matched up with an upper-class Dean's Fellow that will be a source of support and guidance throughout the first year.

Health & Wellness

There's no denying that law school will be challenging. Your physical and mental health will be critical to your success. When problems begin to interfere with your emotional or physical health, your relationships, your work — or life in general — you may need to talk with someone who can help. UCI Law has many in-house, on-campus, and off-campus [resources](#) to assist you in your law school journey.

The [UC Irvine Student Health Center \(SHC\)](#) is a comprehensive outpatient clinic staffed with licensed primary care physicians, psychiatrists, licensed clinical social workers, dentists, physician assistants, registered nurse practitioners, and registered nurses. Medical specialists from various disciplines including orthopedics/sports medicine, gynecology, and internal medicine provide on-site consultation regularly. SHC uses health provider student trainees such as fellows, residents and/or student interns, with licensed professionals, to deliver services to UCI students.

Housing

Law students can take advantage of [seven on-campus communities](#) to live in while attending law school. The benefit of on-campus housing is that it is generally more affordable than off-campus, within walking distance of the law school, and law students will live amongst other graduate and professional school students. Assuming housing eligibility is maintained, the guaranteed housing offer includes priority lease renewal for a student's second and third years.

International Student Center

The International Center facilitates international engagement at UCI to enhance the academic and personal experience of the international community. The International Center staff is committed to serving campus constituents through advising, immigration services, programming, advocacy and outreach. All international incoming JD students must review the [International Center New Student Checklist](#) and follow all necessary requirements.

LGBT Recourse Center
